## RESOLUTION AUTHORIZING A CONTINUOUS FOUR (4) YEAR REAPPRAISAL CYCLE

WHEREAS, Tenn. Code Ann. § 67-5-1601 establishes a general six (6) year reappraisal for updating and equalizing property values for every county in Tennessee for property tax purposes, and

WHEREAS, a six (6) year reappraisal program consists of an on-site review of each parcel of real property over a five-year period followed by revaluation of all such property in the year following completion of the review period and includes a current value updating during the third year of the review cycle and sales ratio studies during the second and fifth years of the review cycle, and

WHEREAS, Tenn. Code Ann. § 67-5-1601 provides that upon the submission of a plan by the assessor and upon approval of the State Board of Equalization, a reappraisal program may be completed by a continuous four (4) year cycle comprised of an on-site review of each real property over a three (3) year period followed by revaluation of all such property in the year following completion of the review period, and

WHEREAS, Tenn. Code Ann. § 67-5-1601(a)(3) authorizes a reappraisal plan specifying a schedule for continuous onsite review or photo review, not to exceed four (4) years, and

WHEREAS, the county legislative body of Benton County understands that by approving such a four (4) year reappraisal cycle, a sales ratio study will be conducted during the second year of the review cycle and the centrally assessed properties and commercial/industrial tangible personal property will be equalized by the sales ratio adopted by the State Board of Equalization;

NOW, THEREFORE, BE IT RESOLVED by the county legislative body of Benton County, meeting in regular session on this the 21st day of January 2025, that:

PURSUANT to Tenn. Code Ann. § 67-5-1601, reappraisal shall be accomplished in Benton County by a continuous four (4) year cycle beginning July 1st, 2025, comprised of an on-site review of each parcel of real property over a Four (4) year period followed by revaluation of all such property for tax year 2029.

**WHEREAS**, the Constitution of the State of Tennessee, in Article XI, Section 12, states that the Tennessee legislature "shall provide for the maintenance, support, and eligibility standards of a system of free public schools"; and

WHEREAS, the fulfillment of this constitutional guarantee is heavily reliant upon adequate state funding, which is vital for equipping schools with the necessary resources to serve the various needs of Tennessee's students; and

WHEREAS, the Benton County Board of Education is charged with governing the school district so that all students, regardless of background needs, or ability, receive the best possible educational opportunities in order to graduate prepared to enter a postsecondary institution or the workforce; and

WHEREAS, Benton County is an educational community that serves a student population of 2,180, with 68% of those coming from economically disadvantaged backgrounds; and

WHEREAS, Benton County School System offers an array of specialized programs including special education services, career and technical education training aligned with local workforce needs, athletics, clubs, band/music, and after school tutorial services which are invaluable for meeting both individual student needs and the Tennessee Constitution's requirement of a free and public education; and

**WHEREAS,** Benton County School System is a cornerstone of the local community, not only providing education services to all students regardless of background, need or ability, but also employing 202 professional educators and 154 support staff members; and

WHEREAS, Benton County School System is committed to maintaining local control over its schools, ensuring that they are reflective of the community's needs and values; and

WHEREAS, Education Savings Accounts (ESAs) threaten the district's ability to maintain the quality of its educational offerings as ESAs would divert state funds to private actors and disrupt local control of education. The ESAs as being proposed, would not hold private actors to the same accountability as public schools currently are under. This being the case, it would prevent true accountability for the funds being diverted away from public schools to private actors.

**NOW THEREFORE BE IT RESOLVED,** that the Benton County Board of Commissioners hereby expresses its opposition to the Governor's "Education Freedom Act" as well as any other voucher or Education Savings Account legislation due to the immediate and yet to be determined long range detrimental impacts these programs will have on our students, schools, and community.

**BE IT FURTHER RESOLVED,** that the Benton County Board of Commissioners urges the Tennessee General Assembly to consider the effects that Education Savings Accounts will have on local schools' districts and to instead seek out ways to support and strengthen public schools throughout the state.
